By 2024, assuming a possible increase of about 15% in similar cases, losses in Italy may account for up to 20 – 25 billion Euros.

"In 2020, ICT Security investments amounted to 145 billion dollars globally, of which 1,5 spent in Italy. It may look an exorbitant figure but this is not the case, if we had to consider that for every dollar invested in security, 7 account for losses\*" explains Emiliano Papadopoulos, CEO at Allnet.Italia, who continues: "In this scenario, it is clearly understandable how Cybersecurity represents an increasingly strategic solution to ensure business continuity, thus turning to be one of the most important priorities of a company, whatever its size or sector it may be in. **Allnet.Italia**, has continually widened its offer in cyber-security over the years, thus predicting its great potential.
